### 8. Trustee Report – Susan Miller

- a. The Board accepted the resignation of Trustee Jacqueline Shotbolt, effective Oct. 31, 2024. As of that date, Shotbolt will no longer reside within the ward in which she was elected, disqualifying her as an EIPS trustee. As outlined in the Education Act, section 81 (2), a by-election isn't required during the fourth year following a general election as long as the number of Board vacancies is less than the quorum, plus one. As such, EIPS will not hold a by-election. Instead, the remaining trustees will assume Shotbolt's duties.
- b. As of September 2024, EIPS is the 6th largest school division in Alberta, employs 1540 staff, oversees 42 schools and has 17,750 registered students. Our schools are located in Sherwood Park, Strathcona County, Lamont County, City of Fort Saskatchewan and Vegreville, County of Minburn.

#### **Assurance Reviews:**

c. The Board of Trustees is elected to represent the public and is responsible and accountable to that public and to the Provincial Government for the expenditure of the Divisions \$200 million annual budget. For us, Assurance Review meetings and discussions around department and school education plans, provides us with a wealth of information to fulfill our fiduciary responsibilities to ensure our division is spending its resources appropriately and has plans in place to support achievement of the goals and outcomes identified in our 4 year Strategic plan.

Every year, Alberta Education requires school divisions to submit an Annual Education Results Report. The document serves as the key planning and accountability tool for sharing information about the Division with stakeholders. Annually submitting the report ensures the Division education plan and results align with Alberta Education's vision, mission, goals, outcomes and performance measures for public education.

Trustees had the opportunity to participate in assurance reviews for the Central Office Departments. Next week, Trustees will be going to schools to hear and celebrate the great and exciting work that is happening all over the Division. We will also hear some of the challenges schools are facing and what strategies will be implemented to overcome those challenges.

d. The Calendar Survey closed October 2!51. There were 5,815 respondents.

Administration will bring forth a recommendation to the Board. The recommendation will be discussed and voted on at the November Board Meeting.

e. On October 315\ Bill 27, Education Amendment Act, 2024, was introduced in the Legislative Assembly. Amendments are focused on improving transparency, resulting in greater consistency for students, parents and teachers.

If passed, for students under 16 years of age, schools must obtain parental consent before a new gender-related preferred name or pronouns can be used by school authorities. For students aged 16 years or older, parents must be notified, but consent is not required. If parental notification is reasonably expected to result in psychological or emotional harm to the student, or if the student requests assistance, the principal shall ensure the student receives assistance, prior to parental notification.

For subject matter dealing primarily or explicitly with human sexuality, gender identity or sexual orientation, school authorities must notify parents and provide parents the option to opt-in their child for this instruction. The proposed amendments would come into effect upon September 1, 2025.

- f. Bill 27 would also introduce changes to support information sharing with families and establish clear expectations for continuity of education during emergencies.
- g. Bill 29 would require organizations, including schools, to maintain policies that would ensure female leagues and divisions are limited to only female-born athletes. The Bill would also identify reporting requirements, including the establishment of new co-ed leagues, if required.
